### UPDATE ON AUDITS

Trustee Judnita Smith stated she would like to strike the update on the Audits tonight due to a Finance Meeting on Thursday, June 18, 2015 at 5:00 pm. To address that issue then and the Auditor will be there to.

Mayor Dorothy D. Armstrong mentions that she had contact with the Auditor and a Special Meeting will be on Tuesday, June 16, 2015 with everybody that is involved. (Special Meeting 6:30 pm) Closure to 2007/2008 Audit.

Trustee Fitzgerald Roberts stated when he spoke with Ms. Walker 2002, 2007, 2003 and 2004 looking was a disclaimer. I think we need to cease and stop cause we are paying about 40,000 on audits that can't be done so that's about 200,000 to 300,000, let state come in and those peoples responsible for the invoice be prosecuted we can move forward. People that are responsible for the 4 million needs to speak with the State and Prosecutor. Wishing this Administration could have come in with a clean sweep and the state needs to come in and pull the hard drives and paper work. The village should not pay for anybody else to come out and do the audit and the state should come in.

Mayor Dorothy D .Armstrong mention that the state did come in about 3 months ago and inspected the books but the holdup is the audit for 2008. The village can move forward once Ms. Walker completes her audit.

Trustee Michael Smith stated he do not see what's the purpose of having 2 meeting tonight to discuss think should come together and meet on that Thursday and we can move upon recommendation to the board.

Mayor Dorothy D. Armstrong repeated again we will be having a meeting with Robin Walker on Tuesday. I called the meeting with her and I will have the meeting at 6:30 pm.

Trustee Fitzgerald Roberts stated for the record if all us can recalled when Mekhi was here the audit haven't been turn into the state since 2000. (TIF audits)

Mayor Dorothy D. Armstrong stated the village audits have been done up to 2007. (Disclaimer) The audits for TIF have not been done since 2000.

Trustee Fitzgerald Roberts stated that the audits he referring to (TIF) 4 million dollars.

Mayor Dorothy D. Armstrong mention that she will reach out to the County to give and update on what a Forensic audit is. Move forward and be on the same place about what a forensic audit.

The Resolution attempt to get around the Robert Rules of Order by saying it suspending the Robert Rules of Order and not withstanding and the problem with that is this village has an Ordinance that says that it is govern by the Robert Rules of Order, now you can amend the Ordinance, but you cannot suspend and Ordinance with a Resolution.

Legislative Counsel James Vessalli stated Robert Rules of Order is the default and if this board chooses to supersede by its own action you can. Section 2-58 of the Dixmoor Municipal Code (Delgaldo read Section 2-58) The board can overrule.

Corporation Counsel Hubert Thompson Yes you can vote to overrule you can overrule anything, but to overrule and Ordinance you need an Ordinance to overrule and Resolution you need a Resolution.
