AN ORDINANCE AMENDING SECTION 23-12 ENTITLED "IMPOSED; BASIS; RATES" OF CHAPTER 23 WHICH IS ENTITLED "TAXATION"

BE IT ORDAINED by the Village President and Board of Trustees, of the Village of Dixmoor as follows:

Section One: Section 23-12, Chapter 23 of the Dixmoor Village Code of Ordinances is hereby amended as follows:

A tax is imposed on all persons engaged in the following occupations or privileges:

- (a) Persons engaged in the business of transmitting messages by means of electricity, at the rate of five (5) per cent of the gross receipts from such business originating within the corporate limits of the village.
- (b) Persons engaged in the business of distribution, supplying, furnishing or selling gas for the use or consumption within the corporate limits of the village and not for resale, at the rate of five (5) per cent of the gross receipts therefrom.
- (c) Persons engaged in the business of distributing, supplying, furnishing or selling electricity for use or consumption within the corporate limits of the village and not for resale, at the rate of five (5) per cent of the gross receipts therefrom.
