## ORDINANCE NO. 82-

## VILLAGE OF DIXMOOR

AN ORDINANCE AMENDING SECTION 25-81
ENTITLED "WHEN RATES, ETC., ARE DUE;
LATE PAYMENT PENALTY" OF CHAPTER 25 WHICH
IS ENTITLED "WATER SEWERS AND SEWAGE DISPOSALS"

BE IT ORDAINED by the Village President and Board of Trustees, of the Village of Dixmoor as follows:

Section One: Section 25-81, Chapter 25 of the Dixmoor Village Code of Ordinances is hereby amended as follows:

All water rates and charges for residential users shall be due and payable on the first day of January, April, July and October of each year, for the preceding quarter. There shall be added thereto and collected therewith a penalty of Ten Percent (10%) amount so due. (Ord. of 4-10-52, § 1; Ord. No. 74-5, § 2, 4-4-74)

All water rates and charges for industrial, commercial and multi-residential user shall be due monthly with each months bill being due the first day of the second month following that month (i.e. March bill due May 1st).

Section Two: For purposes of this section "residential" shall be defined as any user supplying three dwelling units or less. "Multi-residential" shall be defined as any user supplying four dwelling units or more.

Section Three: This Ordinance shall be in full force and effect and the same shall so remain from and after its passage and approval and all ordinances or parts of ordinances in any manner in conflict herewith be and the same are hereby repealed.
