

AGREEMENT BETWEEN THE VILLAGE OF DIXMOOR, AN ILLINOIS MUNICIPAL CORPORATION, AND DALEY'S MEDICAL TRANSPORT INC., d/b/a BUD'S AMBULANCE SERVICE, AN ILLINOIS CORPORATION FOR PARAMEDIC AMBULANCE SERVICES

WHEREAS, the VILLAGE OF DIXMOOR desires to contract for emergency medical services; and

WHEREAS, BUD'S Ambulance, an Illinois corporation, is a provider of advanced life support/paramedic services licensed by the State of Illinois Department of Public Health; and

WHEREAS, the VILLAGE OF DIXMOOR is empowered to contract with private entities for advanced life support/paramedic services and is desirous of contracting with BUD'S Ambulance., an Illinois corporation, to provide said service; and

NOW, THEREFORE, be it agreed as follows:

This Agreement made this 21st day of November, 2013, by and between the VILLAGE OF DIXMOOR, an Illinois municipal corporation (hereinafter referred to as VILLAGE) and BUD'S Ambulance., an Illinois Corporation, (hereinafter referred to as BUD'S) in consideration of the mutual covenants and promises contained herein as follows:

1. BUD'S shall provide advanced life support/mobile intensive care ambulance services to the VILLAGE for three (3) years commencing December 1, 2013 and continuing until November 30, 2016. The paramedic services provided by BUD'S shall be by paramedics licensed by the State of Illinois together with properly equipped and licensed ambulances, all in conformance with the "Emergency Medical Services Systems Act" rules and regulations relating to the "Emergency Medical Services Act" and "South Cook County Emergency Medical Services Policies and Procedures Manual" as attached hereto as Group Exhibit "A" which we commit to an optimum response time of not more than six (6) minutes of notification. During the term of this Agreement and any extensions thereof, BUD'S shall fully comply with all said rules, regulations and license requirements. In the event that BUD'S is

not in compliance therewith, said Agreement shall terminate at the option of the VILLAGE with written notice to BUD'S. BUD'S shall provide the VILLAGE with copies of any notices received by them that indicates BUD'S is not in compliance as provided for in this paragraph.

2. VILLAGE agrees to pay BUD'S monthly. This fee schedule is attached as "Group Exhibit B".

3. BUD'S shall respond to all medical emergency calls within the VILLAGE on a 24-hour per day basis. BUD'S shall take all necessary measures to operate a sufficient number of paramedic ambulances to respond to each VILLAGE call. However, in the event that all of BUD'S paramedic ambulances are occupied with other calls, BUD'S shall be responsible to have another ambulance respond to the VILLAGE call and in addition, the first ambulance available will respond to the VILLAGE call.

4. BUD'S will be entitled to charge the service recipient(s) its usual and customary fees for all medical and transportation services provided to them. BUD'S alone shall be responsible for collecting said charges from the service recipient(s). Said charges shall be

uniform and a schedule of said charges shall be on file with the Clerk of the VILLAGE OF DIXMOOR.

5. All employee benefits for BUD'S employees shall be the responsibility of BUD'S including but not limited to vacation, FICA, worker's compensation and unemployment compensation.

6. BUD'S shall furnish worker's compensation in the statutory amount as well as professional and public liability insurance in the amount of \$1,000,000.00 to cover all of its employees in the performance of any duties for the VILLAGE. BUD'S shall maintain insurance as in accordance with all Federal, State, and local requirements and certificates of said insurance shall be provided to the VILLAGE naming the VILLAGE additional insured. Said certificates shall provide that notice be given to the VILLAGE in the event that the insurance coverage is terminated for any reason. In the event said insurance is terminated for any reason, or is in an amount below the above specified amounts, the VILLAGE may terminate

this agreement at their option with written notice to BUD'S. Evidence of said insurance shall be filed with the VILLAGE Clerk immediately upon execution of this Agreement.

7. BUD'S agrees to indemnify and hold harmless the VILLAGE, its officers, agents and employees from and against all claims, damages, losses, judgments and expenses (including attorney's fees) arising out of or resulting from the conduct and performance of BUD'S and its employees while acting pursuant to this Agreement.

8. The Police Department of the VILLAGE shall respond in situations where safety could be a concern, i.e., domestic violence, injury due to criminal activity, unruly or intoxicated persons. BUD'S shall have the authority to request that the Police Department respond to calls as provided for in this paragraph.

9. BUD'S shall also comply to the following requirement or concerns:

A. Shall maintain Quality Assurance Program to insure that the best possible patient care is delivered.

B. Shall be able to meet multi-unit responses;

- C. Shall transmit and receive radio communications on frequency 154.070

(the VILLAGE OF DIXMOOR's fire channel);
- D. Shall agree to transport to the nearest appropriate hospital regardless of

the patient's ability to pay;
- E. Shall cooperate with the VILLAGE upon request by providing information

relevant to any conflict or complaint relative to a particular call, and be

amendable to resolution thereof by the Village appointed designee acting

as a mediator;
- F. Shall be able to support public education and community service

programs which demonstrate a commitment to the community, and be

willing upon execution of the Agreement to address civic organizations

and churches if requested to explain the transition;
- G. Shall honor the VILLAGE's current mutual aid agreement for Emergency

Medical Services to surrounding communities.

10. This Agreement may be terminated without cause by either party by giving of written notice of said termination. If notice is given pursuant to this Section, the termination shall be effective thirty (30) days after said written notification.

11. This Agreement and attached Rider represents the entire contract between the parties and may not be modified or amended except by written agreement of the parties. This Agreement and Rider may not be assigned by either party without the prior written consent of the other.



GROUP EXHIBIT B

Listed below are the terms and rates for the contract between the Village of Dixmoor and Bud's Ambulance Service beginning November 15, 2013.

The contract will run for three (3) years as set forth in the Agreement, during which time the monthly billings for services shall be as follows:

December 1, 2013 – November 30, 2014	\$2,945.56
December 1, 2014 – November 30, 2015	adjusted by the CPI
December 1, 2015 – November 30, 2016	adjusted by the CPI

Monthly billings are due on the first day of each calendar month. In addition a clause concerning uncontrollable fuel costs is included. This clause will only activate if gasoline or diesel fuel prices exceed \$3.00 or \$4.00 per gallon, bulk price, and will terminate if fuel prices abate. For example, if the first month of any given year saw fuel prices exceed \$3.00 per gallon, the second month bill would contain an additional line item for a 2% fuel surcharge totaling \$63.93. This charge would not appear on the third month bill if fuel prices dropped below \$3.00 during the second month. Costs in excess of \$4.00 per gallon would result in a 4% surcharge. Monthly payments must be paid within 30 calendar days of the due date.

Note: In lieu of paying the initial monthly fees, Bud's will agree to take ownership of Dixmoor's fully equipped 2 ALS ambulances, at a fairly negotiated market price and apply the services rendered to that purchase price until fully paid. Once the ambulances have been paid through services, Bud's would commence the monthly billings.

RIDER TO AGREEMENT BETWEEN THE VILLAGE OF DIXMOOR AND DALEY'S
MEDICAL TRANSPORT INC., d/b/a BUD'S AMBULANCE SERVICE
FOR PARAMEDIC AND AMBULANCE SERVICES

This Rider to the Agreement Between the Village of Dixmoor and Daley's Medical Transport Inc., d/b/a BUD'S Ambulance for Paramedic and Ambulance Services is made this 21st day of November, 2013, by and between the VILLAGE OF DIXMOOR (hereinafter, the "Village) and BUD'S AMBULANCE (hereinafter, "BUD"S) and shall be part of said Agreement in consideration of mutual covenants and promises contained herein as follows:


1. Group Exhibit A as referenced and attached is made part of the parties' Agreement.
2. Coverage. BUD'S affirms that it has sufficient personnel and EMS vehicles and a back-up system and/or mutual aid agreements with other EMS providers to ensure that when an EMS vehicle is responding to a call and a simultaneous call is received for EMS services within that vehicle's coverage area, there will be adequate coverage for the VILLAGE consistent with the terms and conditions set forth in the parties' Agreement.
3. Notices. All notices required to be provided under this Agreement shall be in writing and served either personally during regular business hours or by U.S. First Class mail addressed with sufficient postage prepaid. Notices served personally shall be effective upon receipt, and notices serviced by mail shall be effective upon receipt.


4. Indemnification. The indemnification obligations set forth in the parties' Agreement shall survive the termination of the Agreement.
5. Applicability and Severability. If any provision of this Agreement or Rider is found to be illegal, invalid, or void, the remaining provisions shall not be impaired and the Agreement shall, to the extent reasonably practicable and feasible, be interpreted to give effect to the parties' intent as expressed herein.
6. Governing Law and Jurisdiction. This Agreement and Rider shall be governed, interpreted and construed in accordance with the laws of the State of Illinois. The Circuit Court of Cook County, Illinois shall have jurisdiction over any and all disputes arising under this Agreement and each Party hereby expressly consents to such Court's exercise of jurisdiction.



ORDINANCE NO. 13-DO-08

**AN ORDINANCE OF THE VILLAGE OF DIXMOOR, COOK COUNTY, ILLINOIS
AUTHORIZING THE VACATION OF PUBLIC ALLEYS**

WHEREAS, the Village of Dixmoor, Cook County, Illinois is a duly organized and validly existing non-home rule municipal corporation created in accordance with the Constitution of the State of Illinois of 1970 and the laws of the State of Illinois, and

WHEREAS, pursuant to Section 11-91-1 of the Illinois Municipal Code whenever the corporate authorities of any municipality, determine that the public interest will be subserved by vacating any street or alley, or part thereof, within their jurisdiction in any incorporated area, they may vacate that street or alley, or part thereof, by an ordinance;

WHEREAS, the Corporate Authorities of the Village of Dixmoor hold within their jurisdiction in an incorporated area the following two real properties for the benefit of the public:

Parcel One.

That part of the 16.00 foot wide northwest – southeast heretofore dedicated public alley lying south of the westerly prolongation of the north line of Lot 11 and lying north of public highway dedicated by document number 7749402 recorded December 16, 1922 and document number 77704141 recorded January 9, 1923 all in Block 8 of Chase and Dyer’s Subdivision (being a subdivision of part of the Southwest Quarter of the Northwest Quarter of Section 7, Township 36 North, Range 14 East of the Third Principal Meridian as per plat thereof recorded July 26, 1892 as document number 1706922).

No P.I.N. Number for the above described parcel,

Parcel Two.

That part of the 16.00 foot wide east – west heretofore dedicated public alley lying west of the southerly prolongation of the east line of Lot 1 and lying east of the southeasterly prolongation of the west line of Lot 11 all in Block 8 of Chase and Dyer’s Subdivision (being a subdivision of part of the Southwest Quarter of the Northwest Quarter of Section 7, Township 36 North, Range 14 East of the Third Meridian as per plat thereof recorded July 26, 1892 as document number 1706922).

No P.I.N. Number for the above described parcel,

which properties are both public alleys (hereinafter, referred to as the “subject alleys”), and are depicted and legally described as Parcel One and Parcel Two on the Plat of Vacation, attached hereto as EXHIBIT A, and made part hereof; and

WHEREAS, the Village President and Board of Trustees have determined that the public interest of the Village to be subserved in such subject alleys warrant the vacation of both said subject alleys; and

WHEREAS, the proposed subject alleys for vacation are depicted and legally described in the Plat of Vacation, attached hereto as EXHIBIT A, and made part hereof.

NOW, THEREFORE, BE IT ORDAINED, by the Village President and the Board of Trustees of the Village of Dixmoor, Cook County, Illinois as follows:

Section 1: Recitals. The recitals set forth above are incorporated herein as part of this Ordinance as the findings of the Village President and Board of Trustees.

Section 2: Vacation; Title To Vacated Property. The Board of Trustees hereby vacate both subject alleys and convey title to said subject alleys to the abutting property bearing the following permanent index numbers:

On the west side of the alley legally described herein as Parcel One: 29-07-138—001, 29-07-138-002, 29-07-138-003, 29-07-138-004, 29-07-138-005, and 29-07-138-034.

On the east side of the alley legally described herein as Parcel One: 29-07-138-032.

On the north side of the alley legally described herein as Parcel Two: 29-07-138-032, 29-07-138-033, 29-07-138-013, 29-07-138-014, 29-07-138-015, 29-07-138-016, 29-07-138-036, 29-07-138-019, 29-07-138-020, and 29-07-138-021.

On the south side of the alley legally described herein as Parcel Two: 29-07-138-035, 29-07-138-028, 29-07-138-029, 29-07-138-030, and 29-07-138-031.

Section 3: Reservation of a Public Utility Easement. If there are any public service facilities in said subject alley or alleys, or part(s) thereof, this Ordinance shall hereby reserve to the Village of Dixmoor or to the public utility, as the case may be, owning such facilities such property, rights of way and easements as, in the judgment of the Corporate Authorities, are necessary or desirable for continuing public service by means of those facilities and for the maintenance, renewal and reconstruction thereof.

Section 4: Authorization to Execute. The Village President and Village Clerk are hereby authorized and directed to execute a Plat of Vacation that reflects the vacation contemplated herein and in substantially the form and content set forth in Exhibit A attached to this Ordinance and made part hereof.

Section 5: Authorization to Record. The Village Clerk is hereby authorized and directed to cause a true and correct copy of this Ordinance, together with the original Plat of Vacation, a copy of which is attached hereto as EXHIBIT A, and made part hereof, to be recorded with the Cook County Recorder of Deeds Office of Cook County, Illinois.

Section 6: Other Actions Authorized. The officers, employees and/or agents of the Village of Dixmoor shall take all action reasonably necessary or required to carry out, give effect to and consummate the vacation and actions contemplated by this Ordinance and shall take all action(s) reasonably necessary in conformity therewith including, without limitation, the execution and delivery of documents reasonably required to be delivered in connection with this Ordinance.

Section 7: Severability. If any section, paragraph, clause, or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

Section 8: Conflict with other ordinances or laws. All ordinances, resolutions, motions, or parts thereof in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 9: Publication. The Village Clerk be and is directed hereby to publish this Ordinance in pamphlet form, pursuant to the statutes of the State of Illinois.

Section 10: Effective date. This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.





ORDINANCE NO. 13-DU-09

AN ORDINANCE OF THE VILLAGE OF DIXMOOR, COOK COUNTY, ILLINOIS,
AMENDING CHAPTER 1, GENERAL PROVISIONS, SECTION 1-8, GENERAL PENALTY FOR
VIOLATION OF CODE; CONTINUING VIOLATIONS OF THE DIXMOOR CODE OF ORDINANCES
RELATIVE TO ASSESSING THE COST OF COLLECTING UNPAID FINES
OR FEES AND COSTS TO THE OFFENDER

WHEREAS, the Village of Dixmoor, Cook County, Illinois (hereinafter, the "Village") is a duly organized and validly existing non home-rule municipal corporation created in accordance with the Constitution of the State of Illinois of 1970 and the laws of the State of Illinois;

WHEREAS, Section 1-2-1 of the Illinois Municipal Code (65 ILCS 5/1-2-1) authorizes a default in the payment of a fine or penalty or any installment of a fine or penalty to be collected by any means authorized for the collection of monetary judgments;

WHEREAS, Section 1-2-1 of the Illinois Municipal Code (65 ILCS 5/1-2-1) authorizes the municipal attorney to retain attorneys and private collection agents for the purpose of collecting any default in payment of any fine or penalty or installment of that fine or penalty;

WHEREAS, Section 1-2-1 of the Illinois Municipal Code (65 ILCS 5/1-2-1) also authorizes any fees or costs incurred by the municipality with respect to attorneys or private collection agents retained to collect any default in the payment of any fine, penalty or installment of that fine or penalty to be charged to the offender; and

WHEREAS, the Village President and Board of Trustees of the Village of Dixmoor deem it appropriate to assess collection fees and costs against offenders who have defaulted in the payment of a fine, penalty or installment of that fine or penalty.

NOW, THEREFORE, BE IT ORDAINED, by the Village President and Board of Trustees of the Village of Dixmoor, Cook County, Illinois, as follows:

Section 1: Recitals. The recitals set forth above are incorporated in this Ordinance as the findings of the Village President and Board of Trustees.

Section 2: Amendment to Section 1-8, General Penalty for Violation of Code; Continuing Violations. Chapter 1, General Provisions, Section 1-8, General Penalty for Violation of Code; Continuing Violations, of the Dixmoor Code of Ordinances is hereby amended by deleting said section in its entirety and replacing said section with the following:

Section 1-8, General Penalty for Violation of Code; Continuing Violations.

Whenever in this Code or in any ordinance of the Village any act is prohibited or is made or declared to be unlawful or a misdemeanor or a violation of this Code, or whenever in such Code or ordinance the doing of any act is required or the failure to do any act is declared

to be unlawful or a misdemeanor or a violation of this Code, where no specific penalty is provided therefor, the violation of any such provision of this Code or any ordinance shall be punished by a fine of not more than seven hundred fifty dollars (\$750.00). Upon default of payment of any fine or penalty or installment or any installment of a fine or penalty imposed by this Code, any fees or costs incurred by the Village with respect to attorneys or private collection agents retained by the municipal attorney shall be charged to the offender. Each day any violation of any provision of this Code or of any ordinance shall continue to constitute a separate offense.

Section 3: Severability. If any section, paragraph, clause, or provision of this Ordinance shall be held invalid by a court of competent jurisdiction, all parts that are severable from the invalid part or parts shall remain in full force and effect.

Section 4: Conflict with other ordinances or laws. All ordinances, resolutions, or motions in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 5: Publication. The Village Clerk be and is directed to publish this Ordinance in pamphlet form, pursuant to the statutes of the State of Illinois.

Section 6: Effective date. This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

Ordinance # 13-DC-10

AN ORDINANCE OF THE VILLAGE OF DIXMOOR, COOK COUNTY, ILLINOIS AMENDING CHAPTER 22, STREETS, SIDEWALKS AND PUBLIC PLACES OF THE DIXMOOR CODE OF ORDINANCES TO ADD A NEW ARTICLE AND SECTION RELATIVE TO AN HONORARY STREET NAME SIGN PROGRAM

WHEREAS, the Village of Dixmoor, Cook County, Illinois (hereinafter, the "Village") is a duly organized and validly existing non home-rule municipal corporation created in accordance with the Constitution of the State of Illinois of 1970 and the laws of the State of Illinois;

WHEREAS, Section 11-80-2 of the Illinois Municipal Code (65 ILCS 5/11-80-2) authorizes the corporate authorities of each municipality to regulate the use of the streets and other municipal property;

WHEREAS, Section 11-80-14 of the Illinois Municipal Code (65 ILCS 5/11-80-14) also authorizes the corporate authorities of each municipality to regulate and prevent the use of streets, sidewalks, and public property for signs and sign posts; and

WHEREAS, pursuant to Section 11-80-19 of the Illinois Municipal Code (65 ILCS 5/11-80-19), the corporate authorities have the authority to change the name of any street within its municipal boundaries;

WHEREAS, many municipalities in the State Illinois and throughout the United States have implemented an honorary street designation program whereby streets or portions of streets are designated in honor of a person found by the Corporate Authorities to have a significant positive local impact; and

WHEREAS, the Village President and Board of Trustees of the Village of Dixmoor desire to establish and adopt policies and procedures for an Honorary Street Name Sign Program that allows Village citizens an opportunity to honor people that have made significant contributions to the Village;

NOW, THEREFORE, BE IT ORDAINED, by the Village President and Board of Trustees of the Village of Dixmoor, Cook County, Illinois, as follows:

Section 1: Recitals. The recitals and legislative findings set forth above are herein incorporated and made a part of this Ordinance.

Section 2: Amendment to Chapter 22, Streets, Sidewalks and Public Places. Chapter 22, Streets, Sidewalks and Public Places of the Dixmoor Code of Ordinances is hereby amended by adding a new article and section thereto, Article V, Miscellaneous Street Regulations, Section 22-81, Honorary Street Name Sign Program, to read as follows:

Article V. Miscellaneous Street Regulations

Section 22.81. Honorary Street Name Sign Program.

- (a) Purpose. The Honorary Street Name Sign Program (the “Program”) provides citizens of the Village of Dixmoor (the “Village”) with an opportunity to recognize and honor people who have made significant contributions to the Village as determined by the Village President and Board of Trustees. The Program establishes an honorary street designation on a portion of a public roadway or street that is intended to call attention to the honoree. The street designation does not in any manner alter current addressing for postal, emergency response or similar services provided by the Village or any outside entity.
- (b) Eligibility. The Program is intended to recognize Village residents that have had a significant positive impact on the Village of Dixmoor. Requisite criteria which shall be considered include, but are not limited to, the following: (1) the honoree has resided in the Village of Dixmoor at least five (5) continuous years during his or her lifetime, during which time such honoree shall have preferably resided on the street in question; (2) the honoree is associated with the geographic location in which the designation is sought, i.e., lived or worked at the location requested for recognition or where honoree’s surviving family resides; (3) the honoree has had a close association with the Village and a distinguished career in which high service has been rendered to or distinction brought to the Village, (4) there is a reasonable relationship between the importance of the street being named and the distinction of the person whose name it will bear and (5) the significant cultural, historic, or humanitarian efforts of the honoree.
- (c) Application. Dixmoor residents wishing to propose such designation shall fully complete the application form provided by the Village, which application form shall require the submission of a typed statement containing no fewer than 350 words regarding the significance of the person being honored, the person’s history of residence in the Village, preferably including duration and location and why a particular section of street has been requested for the honorary designation, and a petition of support for the proposed honorary street name designation being requested containing the complete names, addresses and signatures of no fewer than fifty (50) residents of the Village, and which includes the signatures of at least seventy-five percent (75%) of the property owners on the section of the street being requested for the honor. The petition (and each page thereof, if applicable) shall be legible and witnessed by one individual other than the applicant and be notarized prior to its submittal. Failure to fully complete the application may result in its denial or may lead to significant delays in the approval process.

- (d) Fee. The nonrefundable fee for an honorary street name sign application is seventy-five dollars (\$75.00), which shall accompany the application when submitted to the Village Clerk's office.
- (e) Review Procedure. The completed application shall be submitted to the Village Clerk's office at the Village Hall. After ensuring that the application has been fully completed and accompanied with all required submittals and the required fee, it will be presented to the Village President for review and consideration. If the application is found to be acceptable, the Village President will then present a related resolution drafted by the Village Attorney to the Board of Trustees for consideration.
- (f) Legislative Action. The decision to designate an honorary street name is purely legislative in nature. The Village President has sole discretion to place the matter on the Village Board agenda. The Board has the sole authority to grant or deny the designation. Upon final Board approval, the Public Works Department will order the necessary signage and implement the honorary street name designation.
- (g) Designation Signage. The name printed on the honorary signage must not in any way conflict with or be confused with another official street name sign in the Village. The honorary street name sign shall be placed directly below or adjacent to the official street name sign on a Village street pole closest to the honoree's place of residence, work, or residence of the honoree's surviving family, or as the Board may otherwise deem appropriate and suitable. The honorary sign must be brown and white to ensure it stands apart from the Village's official street signs. Honorary street designations shall be limited to one block in length.
- (h) Number and Duration. Once granted, the honorary street name designation will remain for three (3) years and is intended to be a permanent display of public recognition for those 3 years. At the end of the 3-year period, the honorary street name sign shall be removed and donated to the honoree's family or if none, to the applicant or to such other person as the Village Board determines to be appropriate and suitable. There shall be only one honorary designation per location at any given time. Honorary designations shall be limited to a total of three (3) per year. No honoree shall be selected twice.

Section 3: Severability. If any section, paragraph, clause, or provision of this Ordinance shall be held invalid by a court of competent jurisdiction, all parts that are severable from the invalid part or parts shall remain in full force and effect.

Section 4: Conflict with other ordinances or laws. All ordinances, resolutions, or motions in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 5: Publication. The Village Clerk be and is directed to publish this Ordinance in pamphlet form, pursuant to the statutes of the State of Illinois.

Section 6: Effective date. This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.



To the Village of Dixmoor;

Schinova Elston, was a gentleman among gentlemen. Although his life ended at the tender age of thirty-five, he made a life-time of impact on those in his community and beyond. As a brief testament of the impact he made, the three thousand obituaries distributed at his funeral were not enough for every attendant. And although he was from the small Village of Dixmoor, he was a very proud resident and spoke about it as if it was as big as Chicago.

Even though his love spilled over to surrounding communities, he gave a lot of his time, money, personal property, public service and his heart to his hometown. Four years after his death, there was still over one hundred witnesses who accompanied me to the Village of Dixmoor when I was originally on the agenda to make our street naming request known.

In short, Schinova Elston gave away so much, including over 1,000 free haircuts to Dixmoor residence, during back to school events, job readiness programs and just because. After witnessing a countless number of years of the Village of Dixmoor not having a little league baseball league, he committed himself to re-establishing Dixmoor Little League Baseball organization. So with much effort, hard work and preparation, he was successful in co-organizing and became the President of Dixmoor Little League in the year of 2000. In addition to personally mentoring over twenty young men at a time, he was a youth mentor at Rosa L. Parks Jr. High School in partnership with the Gear Up Project.

None of these accomplishments were a shock to those close to him because we observed his commitment to marriage to his growing family at the age of nineteen. We also observed his recognition as a distinguished member of the Young Ministers Coalition and his leadership as a Youth Pastor. But his elevation didn't stop there; he eventually became an Associate Pastor of Christian Love Christian Church. Although we understand no one is perfect, and neither was he, but his positive characteristics, overwhelmingly were duplicated in a contagious manner, with those young and old in Dixmoor.

Schinova wanted to give so much to the Village of Dixmoor and figured another avenue to serve his community was to become a hearing officer for the Village of Dixmoor. And after serving well in that capacity, he decided to serve his community as a Pastor. In 2001, he established Saved By Grace Kingdom Ministries, Int'l in the basement of his home on Hoyne Street. With that mission being deeply rooted in his heart, he earned a Bachelor of Theology from GMORE Theological Services of America in 2002. He also received an Honorary Doctor of Theology degree in Religious Education in 2006 and earned a Masters in Divinity in the same year.


And because of his exceptional community influence and leadership, he was selected District 1 Overseer of the St. Mark Covenant Church Fellowship under the leadership of Bishop Willie L. Jordan.

Schinova Elston was indeed a community lover, serving on many distinguished boards, including The Napoleon Harris Foundation. He was even hired by the City of Harvey as a community liaison leader, in an effort to bridge the gap between the residents and the local government. Schinova was one of the main community leaders who help hold 'the pride of Dixmoor' fabric together. He made people feel proud of being a part of what he called 'Dixmoor University'.

He was on the frontline of 'Peace Marches', he supported a number of residence in court, he wrote several 'character witness' letters to Judges as well as being a character witness during a murder trial. He constantly gave food and money to those in need, whether he knew them or not. I personally witnessed him give his coat and clothes off his own back. These are just a few things Schinova expressed to show his love for Dixmoor. There aren't enough words to describe the unwavering commitment he made serving to enhance the Dixmoor community. It's like he tried to single handedly change the face of the community. His definition of commitment was 'do what you said you were going to do, long after the feeling you said it in has left you'. It is our desire for the street naming of **Pastor Schinova Elston Sr.** to represent COMMITMENT FOR THE BETTERMENT OF THE DIXMOOR COMMUNITY; to inspire the past, present and future residents of Dixmoor.

We respect the other great men and women of Dixmoor who inspired and preceded him, but we strongly believe posting a street name in Dixmoor with his name on it will exemplify the commitment and pride he had in Dixmoor and encourage residents to continue that legacy.

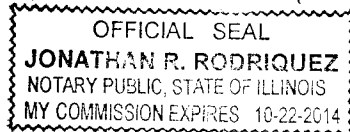

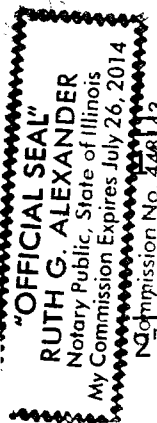
